GASB Statement No. 87— Leases

GASB Statement No. 87 is effective for fiscal years beginning after June 15, 2021, and all reporting periods thereafter. The presentation covers significant changes in the reporting of leases by school districts. There will be examples and tools made available for school districts to prepare themselves for the upcoming FY22 financial statement audit as this statement becomes effective. The presentation will briefly cover all three categories of lease accounting: short-term leases, contracts that transfer ownership and all other leases (lessee accounting and lessor accounting). Accordingly, school districts that lease assets from others (lessees) will report liabilities for all of their leases of land, buildings, and equipment (except for short-term leases and contracts that transfer ownership). This includes leases that previously were considered operating leases and; therefore, were not reported as liabilities. School districts will need to review state and local laws and agreements to determine whether reporting liabilities for leases would impact the government's compliance with debt limitations and bond covenants.


